

## COVID19 - FROM THE DESK OF MHR CEO - ANDRE FOURIE

Dear MHR Panel member

South Africa is experiencing the impact of a pandemic of the COVID-19 strain of the Coronavirus. The situation has unfolded at an extraordinary pace and the outbreak has rapidly shifted from China to Europe and has now reached our shores.

COVID-19 is now being confirmed in quite a few of the provinces within South Africa and the associated containment measures are starting to impact operations within many hospitals. - Payment:
  - For the interim we will pay "Daily payment" panel members on a one day delay e.g. if you have worked Monday day shift, you will be paid on Wednesday instead of Tuesday.
  - o Please note that this interim arrangement will have no effect on weekly payments.
- Entrance guidelines at our clients
  - Please obey the Health and Safety rules and guidelines implemented at our clients.
    Your cooperation will be appreciated.
- Exposure to COVID-19
  - Please inform the MHR coordinator during office hours or the MHR Call centre (afterhours) if you were exposed to either a patient or a person for necessary steps to be taken.
  - Exposure to a patient during working hours will be handled as a WCA claim and the client's protocol for their permanent staff will also be applicable to you as an agency worker.
